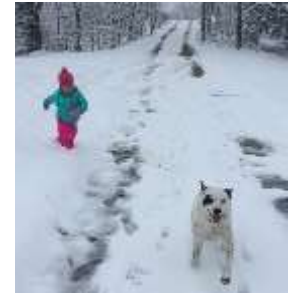




Family Forestland Mini-Workshop Preparing for Land Transfer to Generation "NEXT"

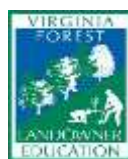
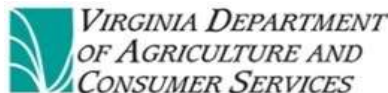

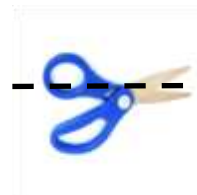
