Randolph Park is located in Pulaski County on 87 acres of land that was generously donated by a lifelong resident of the community, Ms. Evelyn Alexander. Randolph Park was named in honor of Ms. Alexander's parents, Randolph Alexander and Annie Crowgey Alexander. The County of Pulaski began construction of this six million dollar state-of-the-art outdoor recreational facility in the fall of 2000. Funding for the park came from Pulaski County, fund-raisers, and donations.

Coming from Interstate 81, take Exit 98 North on Route 100 towards Dublin. At the first stop light, (surrounded by various fast food restaurants); make a left onto Alexander Road. Randolph Park is approximately one half mile on the right. Traveling on Route 100 South from Dublin, make a right at the stop light (located just before Interstate 81) onto Alexander Road. Look for signs to meeting location in park.

## Learn to Burn Using Fire to Manage Your Land

Whether you manage ten or ten thousand acres, prescribed fire should be part of your land management plan. Burning should be conducted to ensure that your management objectives will be met, while minimizing the likelihood for escaped fire and smoke liability. This one-day workshop will outline benefits of using fire as a management tool on your property, where to go, and who to contact when you need assistance, and how burns are conducted safely and successfully. You will also have the chance to actively participate in a prescribed burn (conditions permitting).

### Morning Field Trip:

- Ignition Techniques/Types of Prescribed Burns

- Hands-on burning experience for all participants (weather permitting)

### Who Should Take this Course:

Private landowners who are interested in using prescribed burning to safely and effectively meet their woodland management goals.

For safety reasons, appropriate attire will be required to participate in the prescribed burn.

#### Appropriate attire includes:

- Nomex shirt and pants (provided)
- Leather gloves (provided)
- Safety glasses and hard hats (provided)
- Clothing made from cotton or wool (synthetic fibers can melt)
- Long pants
- Leather boots

The \$15 registration fee covers all materials, lunch, and transportation to the field sites.
