#### **LILLIAN "EBONIE" ALEXANDER**

Ebonie is the current Executive Director of the Black Family Land Trust, Inc. (BFLT) whose mission is to provide educational, technical and financial services to protect and preserve African-American land ownership in the Piedmont region of North Carolina and Virginia. She has more than 25 years of senior management experience working in leadership positions with nonprofit organizations in the field of land-based community economic development and program design and implementation. She has proven to be particularly effective in building, brokering and managing relationships with and between public and private sector stakeholders at local, state and national levels. Since joining the BFLT in 2009, Ebonie has designed and implemented the BFLT African American Land Ethic and Wealth Retention and Asset Protection (WRAP) programs. Each is a comprehensive intergenerational wealth retention program designed specifically to reduce the rate of African American land loss by educating landowners about strategies to build generational wealth by preserving land ownership. Ebonie has degrees in Public Administration and Nonprofit Management. A proud Virginian who can trace her family's history in the Commonwealth to 1767, she currently resides in Southside Virginia on land that has been in her family for six generations.

#### **JOEL CATHEY**

Joel has served as Resource Manager for Ontario Hardwood Co., Inc., since 2000, which is a grade hardwood sawmill that procures wood over a large portion of Virginia and North Carolina. He currently manages approximately 20,000 acres of forestland in Virginia and West Virginia and himself is a forest landowner and Tree Farmer. He obtained a B.S. in Forestry from N.C. Joel and his wife own Long Branch Farms in Halifax, VA, of which their daughter and son-in-law are preparing to become Next Generation owners.
