## Discovering and Preserving Virginia's History

- The Virginia Department of Historic Resources (DHR), a state agency headquartered in Richmond, has three regional offices housing its Community Services Division—in the City of Salem (Western Region), Stephens City (Northern Region), and Richmond (serving Eastern Virginia). The agency's mission is to foster, encourage, and support the stewardship of Virginia's significant historic architectural, archaeological, and cultural resources. In large part, DHR is a regulatory agency that reviews environmental studies for state and federal projects to assess the potential impacts of projects on significant historic resources, e.g., buildings and sites; and also approves applications for *state and federal tax credits* designed to incentivize the rehabilitation of significant historic resources. Among other important programs, the department also has a *preservation easement* program through which donors elect to preserve their properties well into the future by precluding major alteration, demolition, and development in perpetuity. Thank you for the opportunity to introduce you to The Virginia Forestry Association (VFA). The VFA is the leading advocate for forestry and the private forest landowner in the State of Virginia. Over 700 private landowners are members of the VFA.

This year the VFA was successful in striking down budget proposals in the General Assembly that would have reduced funding for our Virginia Department of Forestry (DOF) and the Reforestation of Timberlands Fund (RT).
