agencies, academic institutions, private conservation organizations, and other interested groups and individuals in response to catastrophic population declines of many bat species due to white-nose syndrome (WNS). Although this guidance is largely focused on cave-hibernating bat species or “cave bats” impacted by WNS in the eastern United States (east of the Great Plains), general recommendations provided herein are likely to benefit other forest-dependent bat species (i.e., “tree bats”), regardless of their conservation status.

- **[Is Reforestation a Profitable Investment? An Economic Analysis](#)**

Historically, reforestation has been a strong long-term investment for landowners. This publication assesses the pine reforestation investment based on current stumpage prices and associated costs to determine whether it still offers attractive returns. We review potential returns from typical pine plantations in the U.S. South. Southern pine reforestation can be an excellent long-term investment even under conservative management assumptions.
