Good Morning Forest Update Subscribers,

Hopefully many of you have been getting some rain these past few weeks. Here in southwest Virginia, I am breathing a sigh of relief as we are getting enough rain to save the gardens from being utter disasters. Personally, I'm ready to move on to fall and the end of hot and/or sticky weather. Soon, right?

This year the e-update has been focusing on different aspects of sustainable forestry. August's topic is protecting biodiversity during forest management activities. **Biodiversity** is defined by the World Wildlife Fund as "*the variety of animals, plants, fungi, and even microorganisms, like bacteria that make up our natural world.*" While care should be taken to protect all aspects of native ecosystems during management activities, the law requires protection of species that are designated as threatened or endangered (T&E).

An **endangered species** is in danger of extinction throughout most or all its range; a **threatened species** is in danger of becoming endangered throughout most or all its range in the foreseeable future. Both are protected under the federal [Endangered Species Act \(ESA\)](#) and Virginia's endangered species regulations. Of course, by their very nature, T&E species are uncommon, and most landowners do not know if any such species are residing on their land.

Fortunately, there are resources available to help landowners. A good starting place is the newly updated Virginia Cooperative Extension Publication "[Guide to Threatened and Endangered Species on Private Lands in Virginia](#)". This publication provides a simple a process landowners can use to determine if T&E species are living on their land.

If you are lucky enough to have T&E species on your land, federal and state agencies are happy to work with you to help you protect them while implementing your forest management activities.
