Good Morning Forest Update Subscribers,

Our thoughts are with all the folks in Virginia dealing with the aftermath of hurricane Helene. If you need help, please visit [VAemergency.gov](#) or call 211 to speak to someone and be connected to resources. The folks at the [Forest Landowners Association](#) have provided some resources that may be useful specifically to woodland owners affected by the storm:

1. **USDA's Emergency Forest Restoration Program (EFRP):** Provides funding to restore private forestland after natural disasters.
2. **FEMA's disaster relief programs:** Offer various forms of assistance for recovery efforts.

This year the e-update has been focusing on different aspects of sustainable forestry. This month I'm going to talk about managing for forest aesthetics. According to the Cambridge Dictionary, aesthetics is "*the quality of beauty something or someone is said to have.*" In the case of forest aesthetics, this applies to the visual impact of management activities. We know the visual impacts of forest management activities, timber harvests in particular, can seem less than beautiful to landowners and the public. In fact, over the years I've heard many landowners describe a recent clearcut as "*it looks like a bomb went off!*" or "*it looked like Mars!*" Of course, those of us

familiar with forest management recognize that this is only a temporary condition – that within a year most people won’t even recognize that a timber harvest occurred. We also know that what looks unappealing to us, looks like beautiful habitat to many species of wildlife that rely on forest disturbances for cover and food. But the public doesn’t always understand this. So, managing to minimize visual impacts of management activities can provide a more visually appealing experience for everyone.

Managing for forest aesthetics during a timber harvest does not need to be costly. Examples include:

- placing log truck landings out of public view
- putting in a bend in the logging access road to block the view of the management activity
- installing roads and harvest boundaries along contour lines and timber types
- revegetating roads with wildlife friendly plants
- leaving a buffer strip of trees along roads

If you are planning to harvest timber on your land, talk to your logger about managing for forest aesthetics.
