Good morning, Forest Update Subscribers,

My dogs and I enjoyed the bout of wintery weather last month. What is it about snow that fills dogs with such joy? Even my 16-year-old hound bounds through the snow like a puppy. I only wish we had a bit more so we could go sledding.

Winter is also a great time to walk through the woods and look for cool things. I suspect that most of us think big trees are pretty cool. Did you know that [Virginia's Big Tree Program](#) maintains a register of the 3 largest specimens of over 300 native, non-native, and naturalized tree species? The register includes information about each tree's size, location, and unique characteristics. The Virginia Big Tree Program is affiliated with the [National Champion Tree Program](#), which is administered by the School of Natural Resources at University of Tennessee. Virginia has consistently ranked among the top-five states for national champion trees. Virginia has 57 sole champions and 39 co-champions, totaling 96 trees in the national register. This ranks Virginia #1 for total trees, trailed by Florida at 64 trees and Texas at 60 trees. Our success is due in large part to a dedicated group of big tree hunters. You can learn more about hunting big trees from the [Virginia Big Trees website](#).

#### **Important Beneficial Ownership Information Reporting Rule Update**

The Beneficial Ownership Information (BOI) Reporting Rule requires most small businesses to file their company with the Financial Crimes Enforcement Network (FinCEN). Small businesses may include LLCs, trusts, and corporations. Many of you may have established one of these business entities for your forest and/or farmland. Please use this link <https://fincen.gov/boi> to learn more. Over the past couple of weeks, there have been updates in ongoing litigation related to this rule. **As of December 26, there is an injunction in effect and companies are NOT currently required to file BOI information with FinCEN.** If you have a small business that qualifies for reporting, but have not yet filed, you can keep up to date with changes here: <https://fincen.gov/boi>. ### **An Urban Forestry Tour in the Star City of the South**

On this tour of Roanoke (and a little of Salem), we will eat lunch at, and tour the grounds of the famous Fishburn Mansion, a 42-room Georgian-revival home built in 1907. We'll learn about using Missouri Gravel Beds to propagate trees, community gardens, and hear from the local tree Stewards.

Next, we'll travel over to Virginia Western Community College, a Bee Campus USA, and have a guided tour of their arboretum.

We'll end the afternoon at Sherwood Memorial Park in Salem where we'll learn about Virginia's Big Tree Program and see Virginia's Champion Atlas cedar. We'll also learn about efforts to protect urban ash trees from the emerald ash borer.
