Good morning, Forest Update Subscribers,

Picture this: Snowville Virginia, Easter Sunday, 2025. Family has just arrived at the farm. Kids and dogs are running wild. And I sneeze. My first official sneeze of the 2025 allergy season.

The symptoms of hay fever, although probably around as long as humanity, were first medically described in 1819 by John Bostock, an English physician. The term hay fever, however, wasn't coined until 1828. But of course, this term isn't quite correct. What we are allergic to is pollen, not hay itself. And pollen is made by most flowering seed-producing plants, including trees. This was quite obvious at an event in Yale Virginia in early April, where the air was hazy with longleaf pine pollen. Pollen dust contains pollen grains; pollen grains consist of one or more vegetative cells and a reproductive cell. Pollen is transported by wind, water, insects, and birds to the female structures of plants, where fertilization occurs (and for trivia lovers – the study of pollen is called palynology).

The immune systems of allergy sufferers mistakenly identify pollen as a harmful substance. To protect us, immune systems produce chemicals, such as histamines, to defend against the pollen. And these chemicals are what cause us to sneeze, wheeze, cough, itch, water, and in general, suffer.

Historically, pollen allergy treatments included opium, topical bleeding, purging, courses of mercury, isolation, seaside vacations, yacht voyages, densely populated towns, smoking tobacco, and inhaling ammonium chloride. While we should obviously steer clear of most of these treatments, the vacationing and yachting do sound more fun than the Zyrtec I'm taking.

Fortunately, allergy season for many of us is temporary!
